NYU School of Medicine 3-year Pathway starts off with 5 weeks of Simulation

Most medical schools in the US are 4-year programs consisting of 2 years of basic science and 2 years of clinical training. At NYU, the new curriculum for the 21st century (C21) allows for greater flexibility and integration. This summer NYU School of Medicine began a new 3-year pathway program where selected students complete their MD degree in 3 years followed by the residency of their choice. These students came to NYU for 6 weeks this summer to begin their clinical training. Each week there were Simulation-based healthcare education activities on various topics including: gathering a history, clinical reasoning, basic resuscitation, teamwork, health disparities, health policy, global health, gender and health, cultural competency and the use of interpreters.
