### NYSIM/CMS hosts a successful “Simulation as a Teaching Tool” course in April

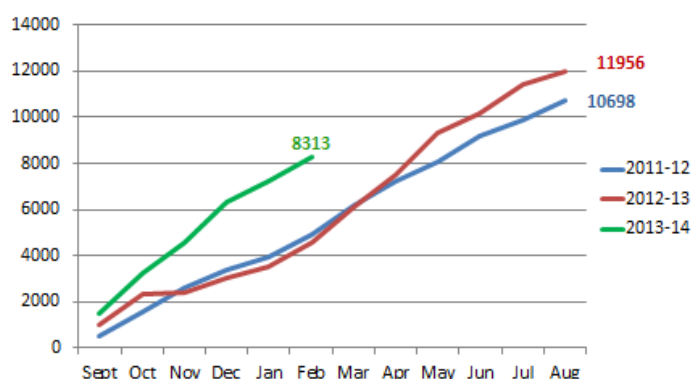
